Narrative: On 8/20/2013 Officer Cohen and I were on routine patrol within the Greer city limits in Greenville County. During this time we observed a F350 truck make a lane change from lane 3 to lane 1 without a signal and then complete a u turn. Officer Cohen turned on his blue lights in an attempt to conduct a traffic stop. Officer Cohen and I approached the passenger side of the vehicle. Officer Cohen was familiar with the passenger Earl Simmons and had knowledge that he had an active FTA with this agency. Officer Cohen asked Mr. Simmons to exit the vehicle. After the warrant was confirmed in hand Officer Cohen placed Mr. Simmons under arrest. I was speaking to the driver(Anita Rhodes) and asked her for her license, registration and proof of insurance. During this time Ms. Rhodes was moving all about the cabin and checked multiple places multiple times for the paper work. Ms. Rhodes at no point would make eye

On the passenger door arm rest I located a bag of green plant material I knew to be marijuana. Based on Mr. Simmons sitting in the passenger seat and me having a visual on the driver I had reason to believe the marijuana belonged to Mr. Simmons. I secured the item in my patrol vehicle. I had officer Cohen to stand with Ms. Rhodes as I was speaking with MS. Simmons.</p> <p>I advised Mr. Simmons of his Miranda rights and then asked him if the marijuana belonged to him. Mr. Simmons stated no. Mr. Simmons stated he had breathing problems and was having a hard time breathing. I rolled Mr. Simmons window down and asked if he needed medical attention and he stated no. At this point Mr. Simmons became very aggressive with his words and was making multiple idle threats. The smell of alcohol coming from his person became very strong. At this point I went back to Ms. Rhodes. I asked Ms. Rhodes to step out and come to back to the front of my vehicle. After it was determined that Ms. Rhodes was not under the influence of any alcohol and or drugs Officer Cohen completed a search of the vehicle based on drugs being located in the vehicle. During said search 3 bags of marijuana were located under the drivers floor board. Based on this the driver was placed under arrest for possession of marijuana.</p> <p>while the car was being searched by Officer Cohen, Mr. Simmons continued to speak about his medical condition. Based on this I had Ems come to the scene. Ems arrived on scene and cleared Mr. Simmons of any issues.</p> <p>The vehicle was towed by Eddies.</p> <p>The driver and passenger were transported to the Greer City jail.</p> <p>Ms. Rhodes was issued a citation for improper lane change and simple possession of marijuana.</p> <p>Mr. Simmons was issued a citation for simple possession of marijuana and served with an active fta warrant underlying charge of DUS.</p> <p>Case cleared by arrest.</p>
